### Eligibility & Limitations

Artwork may be submitted in any media in two categories: 2D and Other. Work must be original and completed within the last 3 years. All artwork must be exhibition ready: gallery wrapped, framed, mounted and ready to hang with wire hanger in place. (Check website for definition). Work must comply with UPS or FedEx size and weight limitations.

### Digital Files

Attach the following information to the files: *artist's name, title of work, medium, size, date, entry number*. **Please indicate the top of your work.** Images of non-accepted works will be returned with the jury notification card. Images of accepted works will not be returned.

## JURYING & AWARDS

Jurors chosen by the Shelby County Arts Fest Committee will approve works for exhibition from digital files. SCAF or the jurors reserve the right to reject, upon arrival, any submissions whose quality was not discernible in the file. Entry fees will be used for awards of 1st, 2nd and 3rd places in each of the two categories. Judges will determine awards from accepted works installed in the gallery. One "People's Choice" award will be chosen by gallery visitors during the exhibit and announced at the close of the exhibit.

### Delivery and Return of Works

Works may be delivered to the reception desk during their regular business hours. For works shipped by carrier, artists are responsible for all shipping charges and transit insurance to and from the venue. Works must be shipped by FedEx or UPS and must be shipped with return postage/insurance payable to Shelby County Arts Fest. Include a completed Authorized Return Shipping label from the chosen carrier. All containers and shipping materials MUST be clearly marked with the artist's name and address and must be sturdy and reusable with appropriate shipping instructions. Works will be returned in the cartons in which they are received. All packing must be of professional quality and meet shipping company guidelines.

### Exhibition Permission & Insurance

Work is not insured by the Shelby County Arts Fest or Grover Museum. Artists will need to provide their own insurance. Work will be included in the show only if the signed Exhibition Entry Form is received with the work.
