**October 14th** - Exhibit opens with Artist Reception from 10 AM to noon at the Grover Museum.

**November 11th** - Exhibit closes

**November 14th - 18th** - Works must be picked up by 5:00 PM. **Any artwork remaining after November 18th will be discarded.**
